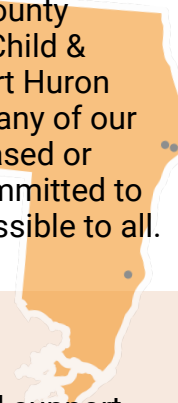
## ABOUT US

St. Clair County Community Mental Health (SCCCMH) is a Certified Community Behavioral Health Clinic that provides comprehensive behavioral health services and supports for adults with mental illnesses, children with serious emotional disturbances, individuals with intellectual/developmental disabilities, and individuals with substance use disorders.

Our approach is centered around you, focusing on personalized care plans. We believe that true healing involves the mind and body working together.

The People's Clinic for Better Health, located at our main office in Port Huron, provides primary care services, including treatment for routine illnesses, chronic condition management, and specialist referrals. When you choose SCCCMMH and The People's Clinic, you'll benefit from the expertise of a treatment team, ensuring coordinated care for your physical and mental well-being. Genoa Pharmacy, inside our Port Huron location, offers convenient prescription filling.

We have offices in Port Huron, Marine City, and Capac to serve St. Clair County residents close to home. Our Child & Family Services location in Port Huron serves children of all ages. At any of our convenient locations, home-based or telehealth services, we are committed to making high-quality care accessible to all.

Trained professionals will help you determine your eligibility for services through SCCCMMH. If you qualify, costs may be covered by Medicaid or private health insurance plans. We offer a **sliding fee scale** to help with out-of-pocket expenses. If you don't meet the criteria for SCCCMMH services, we can provide valuable information about other treatment providers in your area.

When you call the **Access Center**, licensed clinicians are ready to provide immediate assistance and customer service.

In the event of a mental health emergency, our **Mobile Crisis Unit** offers by-phone and in-person assistance. Crisis response services are **available to all St. Clair County residents**, and you do not need to be enrolled in SCCCMMH services to access crisis care and support.
